Confidentiality:

You represent that you have the authority to bind the entity to these terms. If you do not have such authority or are not willing to be bound by these terms, do not view or access the Edison Confidential Information. By accessing or viewing the Edison Confidential Information you acknowledge and agree that these files are the confidential information and trade secrets of Edison. You will use the same degree of care that you use to protect the confidentiality and trade secret status of the Edison Confidential Information as you do to protect your own confidential information of like kind (but not less than reasonable care) and you will not use the Edison Confidential Information for any purpose other than to use the services of Edison. Except as otherwise authorized by Edison in writing, you agree to limit access to the Edison Confidential Information to those who need that access for these purposes and who have executed confidentiality agreements with you containing protections no less stringent than those in these terms. You will not disclose Edison Confidential Information to any third party other than your affiliates, legal counsel and accountants without the other Edison's prior written consent and you will remain responsible for your affiliate's, legal counsel's or accountant's compliance with this paragraph. You may disclose the Edison Confidential Information to the extent compelled by law to do so, provided you give Edison prior notice of the compelled disclosure (to the extent legally permitted) and reasonable assistance, at Edison's cost, if Edison wishes to contest the disclosure. These terms do not apply to any information that: (i) is or becomes generally known to the public without breach of any obligation owed to Edison, (ii) was known to you prior to its disclosure by Edison without breach of any obligation owed to Edison, (iii) is received from a third party without breach of any obligation owed to Edison, or (iv) was independently developed b
